1. Food Vendors will be located in Festival Park and outside up town on the street of Main and Center.
  2. The application fee is \$400.00 and **MUST** be submitted with this form. **THIS IS A NON REFUNDABLE DEPOSIT, AND IT WILL ONLY BE REFUNDED IF YOUR APPLICATION IS DENIED OR REASONABLE CAUSE.**
  3. **THERE WILL BE NO PERCENTAGE TAKEN OR ANY OTHER FEES FOR THE FOOD VENDORS ONLY. THIS IS ONE FLAT FEE. ALSO, THE \$400.00 IS FOR EACH SPOT USED BY EACH VENDOR.**
  4. Set-up will be from 9:00 to 5:00 p.m. on Friday, March 20, 2009. **YOU MUST BE SET UP BY 10:00 A.M. EACH DAY OF THE FESTIVAL. PREFERENCE IS FOR THOSE PARTICIPATING ALL 7 DAYS ONLY.**
  5. All spaces are secured at night and throughout the week; a security guard will be in the area from 11:00 p.m. to 7:00 a.m. throughout the week. **THIS IS ONLY PERTAINING TO FESTIVAL PARK. OTHERWISE LOCAL LAW ENFORCEMENT WILL BE IN THE AREA AND NOTHING IS A GAUNTEE. YOU ARE RESPONSIBLE FOR YOUR OWN PROPERTY.**
  6. Electricity is available.
  7. We **DO NOT PROVIDE TABLES AND CHAIRS.**
  8. We assume photographic rights for publicity purposes. Please let us know if you object to this. **THIS MUST BE IN WRITING AND SUBMITTED WITH THIS APPLICATION.**
  9. Photographs **MUST** accompany application of the trailer and or stand you will be using. The committee has the right to ask the vendor to leave if photo is misleading or items are not as shown on the starting date of set up.
  10. **ALL DECISIONS ARE FINALIZED BY THE DIRECTORS, COMMITTEES, AND BOARD MEMBERS AT THE TIME OF REVIEW OF AND APPLICATION, PHONE CONVERSATIONS, WRITTEN DOUCUMENTATION, E-MAILS, OR FAXED INFORMATION.**

ALL CANCELLATIONS MUST BE IN WRITING AND FORWARDED TO THE PA MAPLE FESTIVAL OFFICE AND THE LETTERS WILL BE REVIEWED BY THE BOARD AT THE TIME OF SUBMISSION.
